SPEAKERS BIOS

Antonio Tajani

Born in Rome on 4 August 1953, Antonio Tajani graduated in law from the University of Rome "La Sapienza". During his military service, he was an officer in the Italian Military Air Force. Mr Tajani worked as a journalist for more than 20 years, initially on the RAI Radio (Radio 1) including time as their special envoy in Lebanon, the Soviet Union and Somalia. He was subsequently the head of the Rome editorial office of the daily newspaper 'll Giornale'.

Mr Tajani was among the co-founders of Forza Italia and was first elected to the European Parliament in 1994 where he served until 2008 when he was appointed as European Commissioner for Transport, in which capacity he was active in promoting the extension of passenger rights. In 2010 he became the Commissioner for Industry and Entrepreneurship and pushed for ambitious re-industrialisation goals and "green growth" by supporting SMEs, notably through the Payment Delays Directive and the Entrepreneurship 2020 Action Plan.

He returned to the European Parliament in 2014 becoming one of its vice-presidents. In January 2017 Antonio Tajani was elected President of the European Parliament on a programme that placed great emphasis on bringing the EU closer to its citizens.

Federica Mogherini

Federica Mogherini is the High Representative of the Union for Foreign Affairs and Security Policy and Vice President of the European Commission since 1 November 2014. She was the Italian Minister for Foreign Affairs from February to October 2014 and a Member of the Italian Parliament (Chamber of Deputies), where she was elected for the first time in 2008. In her parliamentary capacity, she has been the Head of the Italian Delegation to the NATO Parliamentary Assembly and Vice-President of its Political Committee (2013-2014); member of the Italian Delegation to the Parliamentary Assembly of the Council of Europe (2008-2013); Secretary of the Defence Committee (2008-2013) and member of the Foreign Affairs Committee.

Herman Van Rompuy

Elected as the first full-time President of the European Council in November 2009, Herman Van Rompuy took office when the Lisbon Treaty came into force on 1 December 2009. In 2012, he was re-elected for a second (and last) term starting on 1 June 2012 and running until 30 November 2014. At the time of his first election, Mr Van Rompuy was Prime Minister of Belgium. Prior to that he had served in Belgium as Speaker of the House of Representatives (2007-2008) and in several government positions, including as Vice-Prime Minister and Minister of Budget (1993-1999), and as Secretary of State for Finance and Small Businesses (1988). In 2004, he was granted the honorary title of Minister of State. Herman Van Rompuy was economist at the National Bank of Belgium, when he began his political career, in 1973, as national vice-president of his party's youth movement. He was president of the Flemish Christian Democrats (1988-1993). He served in the Belgian Parliament, in turn as Senator (1988-1995) and Member of Parliament (1995-2009). Herman Van Rompuy is professor at the universities of Leuven and Louvain, at the College of Europe in Bruges and at Sciences Po in Paris, and he is the President of the European Policy Centre.

Christian Leffler joined the European Commission in 1996, where he took up the post of Commission "Antici" and Head of the unit in the Secretariat General responsible for the coordination of relations with the Council of Ministers. In 1999, he became the Deputy Head of the Private Office of the Right Honourable Chris Patten, European Commissioner for External Relations. From 2002 until 2007, he was Director in charge of the Middle East and South Mediterranean in the European Commission's Directorate General for External Relations. He then spent three years as Head of Cabinet of Mrs Margot Wallström, Commission Vice President for Institutional Relations and Communication. During 2010 Mr Leffler was Deputy Director General of the DG for Development and relations with African, Caribbean and Pacific States, as well as a senior adviser to EU High Representative for CFSP and European Commission Vice-President Catherine Ashton, assisting her in the preparation for the establishment of the new European External Action Service. From the beginning of 2011 to 2015 he was Managing Director for Americas with the European External Action Service. Mr Leffler took up his current position on 16 September 2015.

Stefano Manservisi is the Director-General for International Cooperation and Development (DEVCO) at the European Commission since May 2016. An Italian national, he previously served as Head of the Private Office of Federica Mogherini, High Representative of the Union for Foreign Affairs and Security Policy and Commission Vice-President. In 2014, he was the Head of the Delegation of the European Union to Turkey. Before that, he held other positions at the Commission, including as Director-General for Migration and Home Affairs and Director-General for Development and Relations with African, Caribbean, and Pacific States. He has also headed the Private Offices of the Commission's President Romano Prodi and Commissioner Mario Monti and served in the Private Offices of the Commission's Vice-President Filippo Pandolfi and of Commissioner Francesco Vanni d'Archirafi. A lawyer by training, he enjoys teaching and has been a visiting professor at the University of Bologna, University of Roma III, and the College of Europe.

Santiago Fisas has been an MEP since 2009. He is a lawyer from Catalonia and graduated in Company Management at IESE. He was vice-president of SATI (textile company) from 1980-1996 and vice-president of the Spanish High Sports Board 1996-1998. He held the position of Secretary of State for Sports from 1998-1999 and President of the PP Municipal Council of Barcelona from 1999-2003. He was also a Minister in the Madrid Regional Government (Culture, Sports, Tourism, Youth) from 2003-2009. Mr Fisas is a member of the Spanish Olympic Committee.

Fabio Massimo Castaldo was born in 1985 and is one of the youngest members of the European Parliament. He studied Italian and French law in Rome and Paris and was elected to the European Parliament in 2014 as a member of the Movimento 5 Stelle (Five Star Movement). He is member of the Committee on Foreign Affairs and the Committee on Constitutional Affairs (for both of them he is also coordinator for the EFDD group), as well as a number of interparliamentary delegation, principally covering the Southern Neighbourhood and Latin America. He is also the European Parliament rapporteur on EU relations with Tunisia and the Lead-Member for the European Parliament's Young Political Leaders Programme. He has been an active participant in several election observation missions.

Šimon Pánek is the executive director of <u>People in Need</u>, the Czech humanitarian organization, which he co-founded in 1992. The group provides humanitarian aid and solidarity for human rights and civil society, principally in authoritarian or conflict-ridden states and zones, including Chechnya, the Balkans, Belarus, Ukraine and Cuba. A former Czech student activist during the 1989 Velvet Revolution, Mr Pánek was a student leader of anti-regime occupation strikes. He became a foreign policy specialist on the Balkans and human rights issues in the presidential administration of Vaclav Havel. A recipient of the 2002 Czech State Medal of Merit and the 2003 European of the Year Award, he has chaired the Board of the Open Society Fund - Prague, and is a member of the European Council on Foreign Relations and the boards of the European Partnership for Democracy and of the recently founded Prague Civil Society Centre.

Ms Piri has been an MEP since 2014. In the European Parliament, she is member of the <u>Committee on</u> <u>Foreign Affairs</u> and member of the Delegation to the EU-Ukraine Parliamentary Cooperation Committee and Delegation to the <u>Euronest Parliamentary Assembly</u>. She has a degree in International relations from the University of Groningen. Previously she worked for the European Thinktank WBS (Wiardi Beckman Foundation) and NIMD (Netherlands Institute for Multiparty Democracy). She also worked as political advisor to the Committee on Foreign Affairs / Defence and Security for the S&D Group in the European Parliament. She is a member of the Dutch Labour Party.

Peter Vermeersch is a professor of politics at the KU Leuven (University of Leuven), Belgium. He is currently director of the LINES Institute (Leuven International and European Studies) and affiliated as senior researcher with the Centre for Research on Peace and Development (both at KU Leuven). In 2007 and 2008, he was a visiting scholar at the Minda de Gunzburg Center for European Studies, Harvard University. He is a graduate of the University of Leuven, but he also studied, lived and conducted research in Central Europe and the Balkans. His research focuses on minorities and migration, democratization, reconciliation and nationalism. He is the author and editor of several academic books, including The Romani Movement: Minority Politics and Ethnic Mobilization in Contemporary Central Europe and The EU Enlargement and Gay Politics: The Impact of Eastern Enlargement on Rights, Activism and Prejudice. He also writes for non-academic audiences. In 2011 and 2012 Peter Vermeersch was part of the organizing team of the G1000, a large- scale deliberative citizens' initiative held in Belgium

Paweł Adamowicz is the mayor of the city of Gdańsk, Poland, and a Civic Platform party politician. He studied law at the University of Gdańsk, where he also became a prominent student movement member. He was one of the organizers of the 1988 strike and became the headperson of the strike committee. Between 1990 and 1993 he served as a vice-rector at his alma mater. In 1990, Mr Adamowicz was elected a member of the City Council in Gdańsk and was working in this capacity until 1998, when he was elected as the Mayor of Gdańsk. He has been holding the Mayor's post since then, being consecutively re-elected. In 2016 he was on the shortlist for the World Mayor Prize because Gdańsk is at the forefront of providing immigrants with the facilities to contribute to the city's society, economy and culture. The city has developed and invested in long term strategies as well as day-to-day measures to successfully integrate newcomers from different countries. Mr Adamowicz describes himself as a supporter of empowered local governments, devoted to strengthening local democracies in Central-Eastern Europe.

Gabriel Delacoste

Gabriel Delacoste is an activist, political scientist and member of the Frente Amplio coalition from Uruguay. He teaches in the University of the Republica, regularly writes in the national press, and was active in recent political campaigns such as the "No a la baja" movement which successfully prevented the reduction of the criminal age in a two-year mobilization campaign. Attracting and involving many young Uruguayans the campaign helped them to become politically socialized and active. Gabriel Delacoste's recently launched initiative "Entre" offers discussions and seminars and seeks to build a bridge between culture and politics.

Irene Wairimu Mwangi represents the Murang'a County at the Youth Senate Kenya which was founded in 2014. In her position as the Senate's Director for Communication and Public Affairs Irene informs national policy to address youth concerns at local and national level. She is also a member of the Kenya Youth Taskforce that researches on youth aspirations and provides recommendations for improved youth policies. Between May and August 2017 she worked as a Political Party Special Interest Group Observer for the Election Observation Group monitoring the inclusion of marginalized groups like youth, women and ethnic minority groups in political parties pre-election activities and during election day. Irene Wairimu Mwangi is currently studying a Master in Public Policy at the University of Reading, UK.

Schaake also serves on the committee on Foreign Affairs and the subcommittee on Human Rights. She is the founder of the European Parliament Intergroup on the Digital Agenda for Europe. Furthermore, Marietje Schaake is the Vice-President of the US Delegation and serves on the Iran Delegation and the Delegation for the Arab peninsula. In addition to her parliamentary work, Marietje Schaake is member of the European Council on Foreign Relations, a Commissioner on the Global Commission on Internet Governance and a WEF Young Global Leader in the class of 2014. She serves as vice-president of the supervisory board of Free Press Unlimited.

APTF is a platform to revive, advance, continually challenge and rethink puppetry in the Arab world, providing skills and specialised programmes for experienced and novice puppeteers, including puppet-makers, educators, social workers, human rights workers, and librarians. APTF collaborates with artists, professionals, local and international NGOs from various fields and disciplines to explore new possibilities in the field. APTF opened its School and Theatre in Beirut, Lebanon in 2013.
