Monsieur le Secrétaire général,

Grâce au soutien du Parlement européen, le Comité Français pour l'Union Paneuropéenne avait pu organiser en 1994, à Strasbourg, un important colloque international sur la réforme des Institutions dans la perspective de l'élargissement de l'Union européenne.

Le C.F.U.P. organise le 27 juin prochain à Paris, en partenariat avec l'Institut des Hautes Etudes de la Défense Nationale, un autre colloque international consacré à la Défense de l'Europe, qui a pour objectif de poser la problématique de la défense européenne et de réfléchir aux conditions de sa réalisation.

De nombreuses personnalités de plusieurs Etats européens sont pressenties pour participer à ce colloque et plusieurs membres du Parlement européen nous ont déjà donné leur accord : en premier lieu, M. José Maria Gil Robles, vice-président du Parlement, mais aussi l'Archiduc Otto de Habsbourg, M. Leo Tindemans, le Général Luigis Caligaris, M. Gerardo Fernandez Albor, ainsi que M. Jean-Claude Pasty, co-président du groupe UPE et qui est également membre du Bureau du C.F.U.P. Je vous joins d'ailleurs un programme où vous pourrez constater que ces personnalités auront bien toute leur place dans l'animation de ce colloque.

Cette manifestation où interviendront en particulier des membres du gouvernement français, et qui aborde l'un des grands aspects de la construction européenne, doit contribuer à la prise de conscience des citoyens européens sur les objectifs de la politique étrangère et de sécurité commune qui, avec la politique de défense, sera au cœur de la CIG.

Pour y parvenir, nous devons mettre en œuvre des moyens importants. L'action de notre association se situe en effet dans le cadre de la campagne de communication et de dialogue avec les citoyens européens, décidée par le Parlement européen conjointement avec la Commission.

C'est pourquoi j'ai l'honneur de solliciter auprès du Parlement européen une subvention permettant de réaliser ces objectifs et dont les moyens sont définis dans la note budgétaire jointe.

Je vous prie d'agréer, Monsieur le Secrétaire général, l'expression de ma considération distinguée et de mes sentiments les meilleurs.







Dear Professor Ionescu,

I have received your letter of June 20, 1995 in which you suggest organising a seminar in order to identify a few major political science research interests and to follow them through the Inter-Governmental Conference placing the emphasis on close contacts with and access to the EU institutions through the various stages of the process.

These areas of interest would be monitored by an academic member of your committee and a counterpart from the European Parliament. Participants should concentrate on younger academics from the EU member states but also from Central and East European and other countries.

Your proposal would seem to be of interest to the European Parliament and therefore we are considering granting your committee a subsidy for its realisation. However, since our budgetary possibilities are limited we could only provide a maximum of ECU 24,000 and hope that you could be able to find additional sources in order to meet your financial requirements.

The seminar could be held in Brussels in the premises of the Parliament, perhaps in the second half of November or early December when we will have the results of the reflection group which is preparing the Inter-Governmental Conference.

If you agree to the above proposals I could ask Mr David Martin, Vice President, who as you certainly know, has been recently co-rapporteur on "the functioning of the Treaty on European Union with a view to the 1996 Intergovernmental Conference - Implementation and development of the Union" to discuss further details of organisation with you in my behalf before our final consent.

As far as a possible follow-up for next year is concerned, we could discuss it in due course.

Thank you for your fax dated 10 August.

As explained before, within CINT's Plan of Activities for 1995 this institution will hold the international Conferences *Maghreb : Development and Regional Security* (October) and *European Security* (November-December), in Lisbon. These Conferences are part of the correspondent research projects in CINT.

We renew our invitation to the European Parliament to be present at both Conferences, not only through possible participants but also through a speaker, which we feel will be very important to discuss some possible new ideas, and whom we will welcome with a sincere pleasure.

Given the relevance for Europe and the opportunity of the analysed issues, the fact that a wide range of active participants is planned, that some new ideas are expected and that it is fundamental that the European Union expresses its opinions, we were pleased to invite the European Parliament to have participants and to provide a speaker to both Conferences, possibly delivering a speech (other themes can be agreed) on the political relations between the and the Maghreb (Maghreb Conference) and on the EU's potential role in regional conflict prevention and in confidence building (European Security Conference).

The appointment of both speakers is critically urgent. The speeches can be delivered in any of the adopted languages (english / french / portuguese in the Maghreb Conference and english / portuguese in the European Security Conference).

Independently from this participation and from the presence of a speaker (our invitation is definite and *independent* from any possible material support), we also applied for a possible financial support to help make these international Conferences possible.

Several european countries, NATO and the United States will be represented at both Conferences (and, we expect, the European Parliament). In the first one also Morocco, Algeria and Tunisia will officially participate, and in the second one participants are also expected from the Maghreb, the Middle East, Eastern Europe, Canada as well as the UN (UNIDIR), among others.

The priority of these meetings will be neither the presentation of formal statements nor the production of inconsequent and sterile analysis, as frequently happens in such occasions. On the contrary, the priority will be to seek, within the possible and realistic limits, to generate some value added, even if modest, which may be of interest to the political decision processes.

The proximity of the official Barcelona Conference and the 1996 Intergovernmental Conference in the EU increases the sense of opportunity of these Conferences.

The characteristics of the Conference on Maghreb are enclosed separately.

On what concerns the Conference on European Security, we will namely focus the crisis of identity and of political decision, the new (present or emergent) threats, the context of regional security in several critical areas along the European perimeter, the architecture of collective security and defence and the EU's common foreign and defence policy issue. It is expected that some innovative ideas and concepts may actually be forwarded.

Beyond the Portuguese Foreign Ministry, the National Defence Institute and CINT's members (Dr. Pedro Jordão and Prof. Paul Bracken, Yale University), the speakers are planned to include representatives of the European Union, UN, the United States, the United Kingdom, Germany, Italy, Turkey, Israel, Spain and Morocco. This Conference will underline the need to reinforce the transatlantic relationship and will assess new ideas for the reformulation and reorientation of NATO's role, the EU common foreign and security policy and Europe's security and defence architecture. In September we will mail the detailed plan of this Conference.

These Conferences involve direct costs that, even being established and managed very cautiously, are significant and impossible to be extracted from the normal core resources of CINT (within which the correspondent research is hardly financed).

Consequently, it is impossible to hold these Conferences without ensuring a proper fund raising from external sources. Therefore, we take the liberty to ask for a financial support from the European Parliament for each of these meetings (we enclose their budgets).

For the Conference *Maghreb : Development and Regional Security* we would appreciate you consider the allocation of a contribution of *BF 100.000*. Given the critical proximity of this event, we will need a particularly urgent reply to this request.

To support the Conference *European Security*, we propose a contribution of *BF 120.000*.

The above mentioned amounts seem reasonable and balanced to us, and they are important to make the conferences possible. However, in the case you find other amounts as more adequate, we will appreciate you quantify them.

We look forward to develop future activities that meet the european interests.

Maghreb : Development and Regional Security

Lisbon, 23 -24 October 1995

Interest and Opportunity

Among other issues addressed by CINT's research and intervention, the situation in the Maghreb region receives a deserved attention, given not only its own relevance but also its potential effects for Europe, namely for the mediterranean countries and for the international relations. That influence can be positive or negative, depending on whether the region evolves into development and stability or into instability and virtual collapse. The emergent social, economic and cultural problems, including the Islamic radicalism and the explosive situation in Algeria (which can generate a new Iran-type phenomenon, close to Europe, and which could induce immediate multiplying effects in Morocco and Tunisia), might be sufficient to produce a deep-rooted and very dangerous turmoil of regional, european and international significance.

One should be aware of the fact that these disturbing perspectives refer to a region that, additionally, presents risks concerning nuclear proliferation, drugs production and traffic and massive illegal immigration. Therefore, it is fundamental to conduct a careful social, economic, cultural, political and strategical analysis of this problem, in order to really understand it and to (in due time ...) define and implement corrective actions to the existent vulnerabilities, bearing in mind all the possible implications for the Maghreb, for Europe and for the international stability.

Within this frame, CINT will hold an international conference in Lisbon, on 23-24 October 1995, whose aim is precisely to analyse these issues, to present different opinions and to try to produce innovative ideas and proposals of public and political interest.

The interest for these questions and for the conference is shown by the participation of representatives of several countries such as Portugal, the United States, Morocco, Algeria, Tunisia, Spain, France or organizations such as NATO and (we hope) the European Parliament. This means that the main players and interested parties will be represented at the Conference.

CINT will forward some ideas and proposals concerning the relationships between Europe and the Maghreb, in the fields of regional security and development, which, if justified, may be submitted to the consideration of some governments and international organizations.

Therefore, one of the ultimate goals of the Conference will be to extract some value added that may contribute to a broader understanding of the focused issues and to exercise some influence, even if modest, at the political decision level.

Although centred mainly in the political assessment of the Maghreb context, the Conference is expected to reveal a significant interest not only for policy makers but also for academics and even for corporations involved in that area (corporate strategy, investments and trade planning, political risk analysis) and for energy planners.

Specific Aims

Among others, the following matters will be covered:

- The strategic influence of the Maghreb, regionally, on Europe, on the Atlantic area and in the international context;
- The individual problems and strategic relevance of Morocco, Algeria and Tunisia, in the above mentioned fields, including:
 1. The internal economic, social, religious and political development, vulnerabilities and potential.
 2. The present relations with Europe and with the West, the possibilities to improve them in the development and collective security fields, in a realistic, balanced and implementable way.
 3. The internal and external conditions of stability and security, within the Maghreb and the Mediterranean regions.

The global theme will be addressed according to the following essential assumptions:

- The scope of the analysis will focused on the development and security issues (particularly in Morocco, Algeria and Tunisia), considering that security and development are inevitably linked.
- Security (and, as a consequence, development) in these countries is vital for European security (which , in turn, is a key component of the whole western and international peace and security), thus it seems fundamental to increase the cooperation formulas with the european and atlantic countries.

The Conference will not concentrate on the presentation of inexpressibly formal statements. On the contrary, it will seek innovative, realistic, balanced and implementable ideas.

Accordingly, although the Conference is designed to ensure a high standard of theoretical quality, it will simultaneously promote a very practical approach to the realities at stake.

Conference Planning

Speakers from different nationalities will deliver communications covering the main aspects of the global issue, and debate periods will be included to allow the exchange of comments and opinions.

It is expected that the participants include the speakers, CINT's Members, representatives of the Portuguese government and public administration (namely from Foreign Ministry , the Defence Ministry, the Industry Ministry and the Trade Ministry), of the Parliament, of the European Union (as we expect), of international organizations such as NATO, and also diplomats, academics and corporate leaders.

Contacts with the press will be established.

If justified, some of the emerging ideas and proposals will be conveyed to the governments of several countries and to specific international institutions (such as the UE and NATO), in order to materialise the possible usefulness of the event.

A report will be later published, integrating the delivered communications.

The Conference will be held in 3 languages (portuguese, english and french) with direct translation.

Speakers

The communications will be presented by different experts which are planned to include members of CINT and representatives of the portuguese government, NATO, the European Parliament and a E. Comission (to be confirmed), the National Defence Institute, the United States, Morocco, Algeria and Tunisia.

General approach matters will be covered (for instance, the *Barcelona Conference* by the Portuguese Foreign Ministry, or the contemporary historical background of the regional situation, by Prof. Vasco Mantas, from CINT).

However, the central conceptual guidelines of the Conference will lead to specific speeches concentrating on the internal situation in the focused countries, on the emergent risks for the regional, european and international security.

CINT's President, Dr. Pedro Jordão, will comment on the strategic implications of the regional instability and on international cooperation and integration measures. The National Defence Institute will address the specific iberian security problems vis.a vis the Maghreb, NATO will analyse the interdependence between the european security and the Maghreb. The European Parliament is expected to cover the political relations between Europe and the Maghreb and the E. Comission to address the economic, trade, financial and aid relations and the USA representative is planned to cover the global security context in the Mediterranean area.

From the Maghreb point of vue, Ambassador Aziz Mekouar (Morocco) will comment the Europe-Maghreb relations, Prof. Assia Alaoui (CRSR , University of Rabat, Morocco) will deliver the speech *Morocco: Pole of Regional Stability*, Prof. Habib el Malki (Chairman, Economic Council of Morocco) will analyse the potential and the vulnerabilities of Morocco in the economic and social fields, Ambassador M'Hamede Achache (Algeria) will address the problems related to the internal situation in Algeria and its relations with Europe and Ambassador Ali Tekaia (Tunisia) will produce a similar coverage of Tunisia's situation.

Budget

An international meeting of this kind, involving high level specialists from various countries, using 3 languages with direct translation, incurs into significant costs.

If we bear in mind that the significant core of participants will be formed by the speakers, official representatives, diplomats and members of organizations, who are expected take an active stand at the discussions, these participants will actually be treated as guests of the event. This means that only a small percentage of the participants will pay an attendance fee (corporate representatives, some academics, etc.). In financial terms, this means that the incurred costs will have to be covered by external financial support. We enclose the global budget for the meeting.



CINT - Centro de Estudos Internacionais, is a private, independent association formed in Portugal in December 1993, whose purpose is the analysis of international relations, as a multidisciplinary field, namely on what concerns its political, sociological, environmental and cultural components.

The absolute political independence of CINT does not mean it will be passive or neutral. On the contrary, it means it will be able to present independent ideas, proposals and reports, to forward specific opinions and to propose precise actions, in close constructive cooperation with governmental bodies and international institutions.

CINT is designed to issue reports, opinions and proposals, make studies and hold national and international conferences on relevant international issues, aimed to create a value added contribution, which is a top priority. In fact, CINT tries not only to conduct high quality academic research but also to transform it into practical, real developments. Besides the formulation of ideas, proposals and initiatives, CINT considers a central aim to gradually exercise some influence at the policy making and at the public opinion shaping levels, in what concerns international relations as well as external and security policy.

Covered issues have included European Security and Defence, China and Southeast Asia, the consequences of the Hong Kong / Macau Integration, the Foreign and Security Policy of the USA and Europe in the Post-Cold War, South Africa and its Regional Role, Nuclear Proliferation and Terrorism, Portugal-Spain Bi-lateral Relations, Northern Africa Security, Islamic Fundamentalism, Environmental Development and Conflicts, etc.

Within our activity in 1995 and in the following years, the *Security and Stability in the Maghreb area and their implications for European Security* will constitute a major interest, due to its strategic relevance, namely for the Security of Europe. We will namely focus on :

- The Maghreb strategic importance, specially for the regional stability and for Europe .
- The (internal and external) threats to the regional development, stability and security
- The situation in Algeria, the (global and local) islamic integratist strategy (from inside and from outside the country) to destabilize Algeria (and, through it, also Morocco and Tunisia), the emergence of terrorism

This theme will be addressed under the following guidelines:

- The scope of the analysis will be the security and the development of the region (namely Tunisia, Morocco and Algeria) considering that security and development are inevitably linked;
- The security (thus also the development) of these countries is important for the european own security, therefore we defend that those countries and Europe (namely the European Comission, the European Parliament and security organizations such as the WEU and NATO) must increase their close co-operation and mutual understanding for some balanced and stable joint security and development, in *realistic and gradually implementable ways*.

In October 23-24 we will hold an international conference in Portugal exactly about this issue, where we expect to have the participation of high level specialists from european and maghrebian countries.

This conference will not be intended to issue only vague and inconsistent statements but, essentially, real and innovative ideas and proposals to promote development and security in the Maghreb and the strengthening of the co-operation between Europe and them. We wish this conference to have a high theoretical quality but, at the same time, to focus on a very practical view of these realities and of what can and cannot really be done to improve them. This way, we wish to contribute with some value added to those aims.

Therefore, we are pleased to invite the European Parliament to be represented in that conference by high level specialists and members, to present and discuss ideas and proposals and to express this institution's feelings and opinions on this subject.





Thank you for your phone call. This fax reproduces the one sent on 24/July but apparently lost.


